Do not attempt to correct mistakes on the ballot by making erasures or cross outs. Erasures or cross outs may invalidate all or part of your ballot. You have a right to a replacement ballot upon return of the original ballot.

SHALL the Board of Education of the Rensselaer City School District be authorized to spend the sum set forth in the budget in the amount of \$27,694,567 during the 2021-2022 school year and to levy the necessary tax therefore.

SHALL the School District be authorized to lease and expend therefore, including costs incidental thereto and the financing thereof, an amount not to exceed the estimated maximum cost of fifty five thousand (\$55,000) dollars, and for a term not to exceed five (5) years, the following motor vehicles: three (3) seventy-two passenger school buses.

SHALL the School District be authorized to enter into an agreement with Yankee Trails, Inc. for a five (5) year extension of the lease for the Bus Garage located at 569 Third Avenue Extension, Rensselaer, New York, to commence on July 1, 2021 and end on June 30, 2026, and to include maintenance and upkeep of the District's transportation fleet, for an annual fee not to exceed \$165,000.00.
